

PRIVACY POLICY

Children in Conflict strongly believes in your right to privacy. We work to ensure that any data which we hold is securely protected and used appropriately. This Privacy Policy outlines our commitment to you.

Introduction

Children in Conflict (or "us" or "we") is committed to keeping the trust and confidence of everyone who comes into contact with us. It is therefore important that you know how we collect and use your personal data. This Privacy Policy applies to all personal data collected and used by us when you visit our website, act as a volunteer, attend one of our events or make a donation. This Privacy Policy will outline:

- Personal data we collect
- What we do with your data
- The legal basis we rely on to use your data
- When we may share it with others
- How you can access and update your information

Personal Data We Collect

We collect personal information from you when you sign up for our email newsletter, volunteer with us, fundraise for us, make a donation or otherwise provide us with personal information. This includes your name, email address and other pertinent data you supply Children in Conflict with when engaging with our organization.

Personal data you provide to us includes:

- Your contact details your name and your email address;
- Other data you share with us voluntarily or upon request;
- When you make a donation on our website your name, email address, credit card information, address, and phone number. We use this information to process your donations, and to keep you updated on your donations.
- We may occasionally ask for supplemental information such as your date of birth, how you heard about us or what motivated you to take action, but this will be voluntary and will only be used to help us to improve your experience or ensure we are only contacting you about issues you are interested in.
- Your communication preferences;
- Information about which of our campaigns, services, events or activities you engage with;
- Any other personal information you choose to share with us, such as your job or personal interests.

Information from Third Parties and Cookies

Children in Conflict's website is owned and operated by Children in Conflict. Our website and mailing analytics provider, like all companies, are able to track your visits, confirm the browser, IP address, and device(s) that are being used and this information will only be used for internal reporting and optimization. We do NOT allow third-party vendors or providers to utilize your personal data except in support of internal Children in Conflict operations.

What We Do With Your Data

Children in Conflict collects and uses your personal data on a lawful basis for the purposes described in this Policy. "Personal data we collect" may be used to maintain appropriate business records, to comply with lawful requests by public authorities, and to comply with applicable laws and regulations in response to required legal obligations. Children in Conflict may use your email address for information and direct marketing purposes if you sign up for our newsletter. You can withdraw your consent at any time. In order to do so, see the "Your Rights" section below.

Data Retention

We retain your personal data as long as is required to satisfy the collection purpose unless a longer period is necessary to comply with any legal obligation or to defend a legal claim.

Social Media and Other Websites

Our website may contain links to third-party websites (for example, Instagram, Twitter and Facebook). Following these links will take you off our website. Children in Conflict cannot accept liability for the use of your personal data by these organizations. For more information, please consult the Privacy statements for whichever websites you visit.

Disclosure and Transfer of Personal Data

For the purposes described in this Privacy Policy, we may share your personal data on a need-to-know basis with Children in Conflict colleagues within Children in Conflict and our partner organization, War Child UK (please see here for War Child UK's Privacy Policy).

Children in Conflict's Children Data Collection Policy

We are committed to providing children with particular protection when processing their data. If we process information for children under the age of 18, should they take part in a fundraising event for example, we will require parental consent. In the event that we learn that we have collected personal data from a child under the age of 18 without parental consent, we will delete that information immediately.

Your Rights

You can ask us if we are keeping any personal data about you and you can also request to obtain a copy, request additional information about the processing, and to request we delete or correct your personal information. We will then make the changes that you ask for, except in circumstances where we are required to hold your information for legal purposes, in which case we will explain to you why we still require holding your data.
